In accordance with Chapter 113-29D of the Public Laws of St. Mary's County, Maryland, being part of Article 19 of the Code of Public Local Laws of the State of Maryland, notice is hereby given that a Public Hearing will be held on Monday, April 6, 2020 at 6:00 p.m. at the MetCom Administration Building, 23121 Camden Way, California, Maryland. The Hearing will be held to discuss the proposed Fiscal Year 2021 Capital Improvement Budget, the proposed Fiscal Years 2022-2026 Capital Improvement Plan and the proposed Fiscal Year 2021 Operating Budget and proposed rate changes relating to each budget, to become effective July 1, 2020.
